## **TERMS & CONDITIONS**

## FAMILY AND FRIENDS PROMOTION (1 July 2025 TO 30 June 2026)

- Information on how to enter and prizes form part of these terms and conditions.
   Entry into PEOPLECARE FAMILY AND FRIENDS (the Promotion) is deemed to be
